**TAX LEVY ORDINANCE
BENTON TOWNSHIP
ROAD DISTRICT**

ORDINANCE NO: 04 -23

An ordinance levying taxes for all road purposes for the Benton Township Road District, Lake County, Illinois, for the tax year **2023**, collectable in **2024**.

BE IT ORDAINED by the Board of Trustees of Benton Township, Lake County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of the Benton Township Road District on **December 13th, 2023** does hereby determine and declare that the sum of **One Hundred Sixty-Seven Thousand Three Hundred Twelve Dollars (\$ 167,312.00.)** is

hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for purposes as:

ROAD AND BRIDGE FUND

for the year **2024**.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for the Benton Township Road District.
