**TAX LEVY ORDINANCE
BENTON TOWNSHIP**

ORDINANCE NO. 03 -21

An Ordinance levying taxes for all town purposes for Benton Township, Lake County, Illinois, for the tax year **2021**, collectable in **2022**.

BE IT ORDAINED by the Board of Trustees of Benton Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of **Five Hundred Seventeen Thousand Dollars (\$ 517,000.00)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

ILLINOIS MUNICIPAL RETIREMENT FUND
SOCIAL SECURITY FUND
