**TAX LEVY ORDINANCE  
BENTON TOWNSHIP  
ROAD DISTRICT**

**ORDINANCE NO: 04 -21**

An ordinance levying taxes for all road purposes for the Benton Township Road District, Lake County, Illinois, for the tax year **2021**, collectable in **2022**.

BE IT ORDAINED by the Board of Trustees of Benton Township, Lake County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of the Benton Township Road District on **December 8th, 2021** does hereby determine and declare that the sum of **One Hundred Forty-Nine Thousand Five Hundred Dollars (\$ 149,500.00.)** is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for purposes as:

for the year **2022**.







SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for the Benton Township Road District.


SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


