**TAX LEVY ORDINANCE
BENTON TOWNSHIP
ROAD DISTRICT**

ORDINANCE NO: 04 -22

An ordinance levying taxes for all road purposes for the Benton Township Road District, Lake County, Illinois, for the tax year **2022**, collectable in **2023**.

BE IT ORDAINED by the Board of Trustees of Benton Township, Lake County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of the Benton Township Road District on **December 14th, 2022** does hereby determine and declare that the sum

of **One Hundred Fifty-Nine Thousand Three Hundred Forty-Five Dollars (\$ 159,345.00.)** is

hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for purposes as:

ROAD AND BRIDGE FUND

for the year **2023**.





SECTION 5: That if any section, subdivision or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
