#### BUDGET & APPROPRIATION ORDINANCE LAKE COUNTY CLERK TOWNSHIP ORDINANCE NO. 01-24

**ANTHONY VEGA** 

An Ordinance appropriating for all town purposes for Benton Township. Lake County, Illinois, for the fiscal year beginning February 1st, 2024 and ending January 31st, 2025.

BE IT ORDAINED by the Board of Trustees of Benton Township, Lake County, Illinois.

SECTION 1: That the amounts hereinafter set forth, or so much thereof may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of Benton Township, be and the same are hereby appropriated for the town purposes of Benton Township, Lake County, Illinois, as hereinafter specified for the fiscal year beginning February 1st, 2024 and ending January 31st, 2025.

SECTION 2: That the following budget containing an estimate of revenues and expenditures is hereby adopted for the following funds:

CORPORATE FUND

GENERAL ASSISTANCE FUND

ILLINOIS MUNICIPAL RETIREMENT FUND

SOCIAL SECURITY FUND

SECTION 3: That the amount appropriated for town purposes for the fiscal year beginning **February 1**<sup>st</sup>, **2024** and ending **January 31**<sup>st</sup>, **2025**. by fund shall be as follows:

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in the particular amounts stated for each fund respectively in Section 2, constituting the total appropriation in the amount of \$ 599,950.00 (Five Hundred Ninety-Five Thousand Eight Hundred Fifty-Four Dollars) for the fiscal year beginning February 1<sup>st</sup>, 2024 and ending January 31<sup>st</sup>, 2025.

SECTION 6: That Section 3 shall be and is a summary of the annual Appropriation Ordinance of this Township, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.
