

**MEETING MINUTES**

1. **CALL TO ORDER:** The meeting was called to order by Supervisor Streid at 6:30pm.

- b. **Amendment of Resolution 07-25: Resolution to Recover Rebuild Illinois Funds:** It was motioned by Trustee Livingston and seconded by Trustee Klinger to waive the reading of the amendment into the record. **4 AYES, 0 NAYS. Motion passes.**

It was motioned by Trustee Knobbe and seconded by Trustee Livingston to change the resolution number from 07-25 to 09-25 due to clerical error. **4 AYES, 0 NAYS. Motion passes.**

- c. **Appoint vacant Trustee Position:** Clerk Bronson called for nominations for the position of Township Trustee to fill a vacancy on the Township Board due to not having enough candidates on the ballot. Supervisor Stried said that two resumes were submitted for consideration. He stated that both applicants were invited to attend the meeting. Supervisor Stried nominated Terry Printz due to his local knowledge of the community, engineering background, and commitment to the community. Trustee Knobbe asked if there was a cutoff point for someone to submit their application for the vacant position. Clerk Bronson said that applications can be submitted up until the meeting. She also stated that anyone can submit their name to be nominated during the discussion of nominations. Clerk Bronson called for nominations for the position of Township Trustee. No other nominations were made. At this time Clerk Bronson closed the call for

nominations. It was motioned by Trustee Klinger and seconded by Trustee Livingston to accept the nomination of Terry Printz to fill the vacancy of Benton Township Trustee. **4 AYES, 0 NAYS. Motion passes.**
